The Nevada Early Care and Education Career Ladder is specific to Early Childhood Education. Individuals with degrees in fields other than ECE may still place at the level commensurate with their degree, but must submit official (preferred) or unofficial college transcripts showing at least 30 college credits in ECE or possess a state teaching license with an Early Childhood, Early Childhood Special Education, 0-K or 0-2 Special Endorsement in order to do so.

#### **Coursework Classification**

In order for a course to be considered ECE or related to ECE, it must contain content specific to the direct care, education and development of children between birth and eight years of age, as evidenced by the course title. Courses must have been awarded a letter grade of C or better and attained at a regionally accredited institution of higher education to be considered.
